**THE SOUTH GLOUCESTERSHIRE COUNCIL (The Police Station, Gloucester
Road North.) TREE PRESERVATION ORDER, 2012**

The South Gloucestershire Council, in exercise of the powers conferred on them by sections 198 of the Town and Country Planning Act 1990 hereby make the following Order—

Citation

1. This Order may be cited as the South Gloucestershire District Council **(The Police Station, Gloucester Road North.) Tree Preservation Order, 2012.**

Interpretation


2.- (1) In this Order "the authority" means the South Gloucestershire Council (2) In this Order any reference to a numbered section is a reference to the section so numbered in the Town and Country Planning Act 1990 and any reference to a numbered regulation is a reference to the regulation so numbered in the Town and Country Planning Act(Tree Preservation)(England)Regulations 2012

Effect

- 3.- (1) Subject to article 4, this Order takes effect provisionally on the date on which it is made.
- (2) Without prejudice to subsection (7) of section 198 (power to make tree preservation orders) or Subsection (1) of section 200 (tree Preservation orders: Forestry Commissioners) and, subject to the exceptions in regulation 14, no person shall-
 - (a) cut down, top, lop, uproot, wilfully damage, or wilfully destroy; or
 - (b) cause or permit the cutting down, topping, lopping, uprooting, wilful damage or wilful destruction of,any tree specified in the schedule to this order except with the written consent of the authority in accordance with regulation 23, and, where such consent is given subject to conditions, in accordance with those conditions.
